In most cases, for electronic tax return filers, 2021 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 2–3 weeks after the 2021 electronic IRS income tax return has been accepted by the IRS.

If the parents filed separate 2021 IRS income tax returns, **2021 IRS Tax Return Transcripts** must be provided for each.
